REFUND NOTES

Validation of the injury/illness must be made by a licensed veterinarian/physician and attest that the dog/handler cannot compete at this specific set of trials and/or provide a time period during which the dog/handler cannot compete. Requests from chiropractors, massage/physical therapists, etc. will not be accepted. All injury partial refunds are subject to verification.
