SITE INFORMATION

- Exhibitors and handlers will be responsible for cleaning up after their dogs and themselves in and around the building and parking area and hotels. Poop bags are located throughout the premises for your convenience in picking up after your dog(s). Handlers found to be in violation of either of these policies may be excused by the Trial Committee without benefit of refund.
- Exhibitors and handlers alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Youngsville Agility Club, Teamworks Dog training LLC, its agents, members, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.
- All dogs present must be held on a leash, or confined to a crate except when being judged.
- Crating space will be available in separate climate-controlled building or outside under cover in our designated crating spaces.
- No shock collars allowed anywhere on the grounds.
- No bitches in season allowed anywhere on the grounds.
- Lunch will be available for purchase.
- Individually-wrapped snacks, coffee and bottled water will be available.
- Waiver of Rights – Animals in Distress: The Youngsville Agility Club reserves the right to remove an animal in distress from a parked vehicle or crate, and all persons attending these dog shows hereby waive any claim for damages against the club for such removal.

ENTRY INFORMATION

- RACH and RAE will be offered as classes. Dogs entered in the RACH class will be entered in Master, Excellent B, and Advanced B, and the combined entry fees for these three classes must be paid. Dogs entered in the RAE class will be entered in Excellent B and Advanced B, and the combined entry fees for these two classes must be paid. Once the limit has been reached for Rally, the RACH/RAE Class will be considered closed, and any subsequent entries for this class will be unacceptable in their entirety.
- Closing date for entries: 5:00 pm, Wednesday, April 29, 2026 at the Trial Secretary's home after which time entries cannot be accepted, cancelled, or substituted. Telegraph, emailed, telephone, or unsigned entries cannot be accepted. **Entries not on Official AKC entry forms and photocopies of entry forms without the agreement and rules on the reverse of the Official AKC entry form are NOT ACCEPTABLE.**
- Entries made online for a \$5.00 non-refundable service fee per entry form at <https://www.tfletservices.com/yac-nov-rally-entry-form> or via US Postal Service using entry forms below or generic AKC entry forms.
- Make all checks and money orders payable to: **Youngsville Agility Club or YAC**. Trial Secretary assumes no responsibility for cash sent through the mail. NO ENTRY shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. A fee of \$35 will be charged for any returned check and the exhibitor may be asked to submit cash or money order for future events.
- Returned checks, post-dated checks or declined credit cards do not constitute a valid entry.
- Any entry sent via express mail or any other similar service must be sent "no signature required".
- It is the responsibility of the person submitting the entry form to ensure accuracy of data on the entry form. In the event of errors or cancellation, no refund will be given after the published closing date.
- By providing an email address on the entry form, you agree to electronic correspondence for confirmation letter and judging program. If you would like your confirmation letter and judging program sent via US Postal Service, you may either not provide your email address on your entry or you may specifically request snail mail.
- Transfers will be permitted in accordance with Rally Regulations Ch.1 Sec. 16. Transfers must be submitted at least 30 minutes prior to the start of the trial for which the transfer is being requested. Transfers will also be accepted in advance until Thursday, November 12, 2026 at 5:00 pm at tracy@tfletservices.com, please send from the email address submitted on the entry form and include the

dog's AKC number, classes being transferred from, classes being transferred to, jump height if applicable, and trial(s) applicable to transfer.

- A wait list will be maintained in accordance with Rally Regulations Ch 1 Sec. 24 to fill openings created by entries that are withdrawn before 5:00 pm EDT, Wednesday, October 28, 2026.

REFUND INFORMATION

- Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Trial Committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or complete the show, no refund of entry fee will be made.
- Refunds due to illness or injury of either dog and/or handler will be in the form of a voucher towards a future trial, less \$11 per run. A written veterinarian/physician letter (on office letterhead) must be given to the Trial Secretary no later than one half hour prior to the start of the first class in the trial. Validation of the injury/illness must be made by a licensed veterinarian/physician and attest that the dog/handler cannot compete at this specific set of trials and/or provide a time period during which the dog/handler cannot compete. Requests from chiropractors, massage/physical therapists, etc. will not be accepted. All injury partial refunds are subject to verification.
- Bitches in season: Bitches in season are not permitted to compete in rally trials. The club will refund all but \$11.00 per run for bitches in season that are unable to compete for that reason. Refund requests must be accompanied by a dated letter signed by a veterinarian or email sent by a veterinarian stating the reason that your dog cannot compete. The Trial Secretary must be notified no later than one half hour prior to the start of the first class in the trial. E-mails, phone calls and oral communications will not be considered.
- No entry fees will be refunded if the Trial cannot open or be completed by reason of riots, civil disturbances, fire, acts of God, public emergency, or any other cause beyond the control of the Club.

The grounds will be available on Friday after 3:00 pm for set up (absolutely no earlier). There are signs clearly indicating where parking and tenting are. Anyone caught driving past barriers or disobeying the ground rules will be asked to leave the site without a refund. Youngsville Agility Club and Teamworks Dog Training will not be responsible for any lost or damaged items left at the show site.

DIRECTIONS TO TRIAL SITE

From Points South/East: Take I-40 West to I-440 (Beltline) to Exit 11 (Route 1 North / Capital Blvd). Continue on Route 1 North/Capital Blvd. until it splits at US-401. Follow US-401 North, which splits to the right. You will go through town of Rolesville and enter Franklin County. Pass Rte 96; turn right on 98 East (second light past Rte 96). Pass Spencer's Gate development. At first major road, turn right on Bethlehem Church Rd (road called Clifton Pond Rd on other side). Turn left onto Robbins Rd. Look for white fence on left. Turn left into second gravel driveway at Teamworks Dog Training sign.

From I-40 Headed East: Exit I-40 onto I-540 East. Continue on I-540 and take the exit for 401 north (Louisburg). Go through town of Rolesville. Pass Rt 96; enter Franklin County. Turn right onto 98 East (second light past Rt 96). Pass Spencer's Gate development. At first major road, turn right on Bethlehem Church Rd (road called Clifton Pond Rd on other side). Turn left onto Robbins Rd. Look for white fence on left. Turn left into second gravel driveway at Teamworks Dog Training sign.

From Virginia and Points North of Raleigh: Take I-95 South to I-85 South. Follow Rt 1 South toward Raleigh. Take Rt 98 East. Follow signs to stay on route 98 East. Pass 401. Pass Spencer's Gate development. At first major road, turn right on Bethlehem Church Rd (road called Clifton Pond Road on other side). Turn left onto Robbins Rd. Look for the white fence on the left. Turn left into second gravel driveway at Teamworks Dog Training sign.

From Durham and Points West of Raleigh: Take I-85 North. Take US-70 East to Raleigh. Stay in the right-hand lane. Watch for small sign for Rt 98 East to Wake Forest (it comes up fast). Take Rt 98 East to Wake Forest. You will be on this road for about 40 minutes. Pass Route 50; pass Rt 1. Go through Wake Forest, following signs stay on Rt 98 East. Pass Rt 96. Pass Rt 401. Pass Spencer's Gate development. At first major road, turn right on Bethlehem Church Rd (called Clifton Pond Rd on other side). Turn left onto Robbins Rd Look for white fence on left. Turn left into second gravel driveway at Teamworks Dog Training sign.
